

# *Elite Athletics Center Terms & Conditions*

Please read carefully, sign below, and turn in at Registration:

1. I acknowledge that all payments made to Elite Athletics Center are **non-refundable** and **non-transferable**.
2. I acknowledge that all tuition and other program fees will be automatically drafted through GoMotion using the debit or credit card on file. Payments will be processed on the corresponding due dates as outlined in the 2025-2026 Schedule of Fees in the parent handbook.
3. I acknowledge that a late fee of \$30 will be assessed to athlete accounts for payments made more than five (5) calendar days past the due date.
4. I acknowledge that I am responsible for keeping all information in my GoMotion account up to date and will regularly review my account and billing summary. If my debit or credit card information changes, I will update it in my GoMotion account and/or notify Elite Athletics Center immediately.
5. I acknowledge that all payments must be made on time, and I must communicate fairly about any payment issues. If my account is over 10 days delinquent, Elite Athletics Center may withhold services (e.g. no practice participation) and/or withhold items (uniforms, accessories, etc.) until the account is caught up. Two separate instances of being 10+ days late on payment may result in immediate dismissal from the program.
6. I understand that when my athlete joins Elite Athletics Center, they are joining the program as a whole—not a specific team. Team placement is determined by the coaching staff based on where each athlete's skills can be most effectively utilized.
7. I understand that for my athlete to maintain their current team placement, their skills must remain consistent throughout the season. I also recognize that my athlete's attitude, work ethic, and ability to positively interact with coaches and teammates are essential factors in determining their continued placement on the team.
8. I acknowledge that athletes may be moved to another team at any time, at the discretion of the coaching staff. If an athlete is unable to consistently perform the necessary skills for their current team, Elite Athletics Center staff and coaches may reassign them to a team that better matches their abilities to support both the athlete's development and the competitiveness of the program. Conversely, if an athlete demonstrates the skills required for a higher-level team, the coaching staff may elect to move them to that team to further support their growth and contribution to the program.
9. I acknowledge that a parent or guardian is required to attend one of the scheduled introductory parent meetings, as well as any additional meetings scheduled throughout the 2025–2026 season.
10. I acknowledge that my athlete is expected to arrive on time for practice and remain for its full duration.
11. I acknowledge that only coaches and athletes are permitted in the gym, unless invited by Elite Athletics Center staff.
12. Jewelry of any kind is not permitted during practices, classes, open gym, camps, competitions, or performances. Please refrain from allowing your child to get new piercings during competition season.
13. I acknowledge that once practice wear has been distributed, my athlete is required to wear it to every practice. EAC apparel or black-on-black attire may be worn to classes or Sunday practices.
14. I acknowledge that my athlete is expected to wear athletic shoes to all practices—**no Crocs allowed**. Once the accessories package has been distributed and cheer shoes have been issued, athletes must wear their cheer shoes to every practice. Cheer shoes must be put on upon arrival at the facility.
15. I acknowledge that if my athlete is not picked up within five minutes of their scheduled practice end time, a \$10 late pickup fee will be charged. An additional \$1 per minute will be added for each minute beyond the initial five minutes. If the fee is not paid upon arrival, the fee will be charged to the athlete's account immediately using the payment information on file. Any unpaid fees must be settled with five calendar days, or a \$30 late fee will be applied.

18. I acknowledge that if my athlete is not picked up within five minutes of their scheduled practice end time, a \$10 late pickup fee will be charged. An additional \$1 per minute will be added for each minute beyond the initial five minutes. If the fee is not paid upon arrival, the fee will be charged to the athlete's account immediately using the payment information on file. Any unpaid fees must be settled with five calendar days, or a \$30 late fee will be applied.
19. I acknowledge that my athlete is allowed a total of five (5) absences for the entire season, and I understand that each absence must be documented with a completed absence form.
20. We prioritize the safety and well-being of our athletes above all else. If an athlete needs to "sit out" of practice, a doctor's note is **required**. Should additional practices need to be missed, a meeting with the athlete and parents will be scheduled to develop a plan of action. All injured athletes are still expected to attend all practices, competitions, and events.
21. I acknowledge that cheerleading is a team sport and understand that withholding my athlete from practice should not be used as punishment for bad grades, behavior at home or school, or similar issues. Please choose an alternative form of discipline that does not negatively impact the coaches or teammates, as this could result in dismissal from the team.
22. I acknowledge that Choreography Camp is **mandatory** and that no absences will be allowed on the scheduled dates. The camp will take place in late August and/or early September. We will confirm the exact dates as soon as possible.
23. I acknowledge that the estimated competition fees range from \$600 to \$1,500 and will be paid in seven (7) installments, due on the 15th of each month from September 2025 through March 2026.
24. I acknowledge that my athlete **cannot** be late to team arrival times or meetings at competitions, as this creates significant stress for both coaches and teammates. Being late may also result in the removal of your athlete from the team. I understand that there will be a \$1 fee for every minute the athlete is late after the specified arrival time. . The fee will be automatically charged to the athlete's account using the payment method on file following the competition. Any unpaid fees must be settled within five calendar days, or a \$30 late fee will be applied.
25. I acknowledge that when traveling to competitions or events, our priority is to be with the team and perform to the best of our ability. Activities such as sightseeing, visiting theme parks, family visits, shopping, etc., must not interfere with your athlete's commitment to the team. All meetings or extra practices are mandatory. Curfews must be adhered to, and athletes are expected to always behave appropriately.
26. Parents and athletes are always expected to demonstrate good behavior and sportsmanship. Unruly behavior or disrespect from parents and/or athletes toward teammates, other teams or parents, staff, coaches, or owners will not be tolerated. Failure to adhere to these standards may result in dismissal from the program.
27. I acknowledge that a written notice must be sent via email to **eliteathleticswsnc@gmail.com** to withdraw my athlete from the program. Withdrawal notices submitted to coaches or team parents will not be accepted. I also acknowledge that if my enrollment at Elite Athletics Center terminates for any reason after **August 1, 2025**, a \$300 withdrawal fee will be immediately charged to my athlete's account using the payment method on file.
